TERMS AND CONDITIONS

1. REGISTRATION:

1.1: Enrolling in the Caravan Industry Association of Australia Kid's Club programme secures a booking for the selected days stated on the registration form during the Caravan Industry Association of Australia 2021 National Conference which runs from 5 May through to 7 May 2021.

1.2: Programmes Length: All Kid's Club Programmes may vary in duration depending on the conference timetable.

1.3: Indemnity: The parent/guardian agrees to indemnify Caravan Industry Association of Australia & Coastal Babysitters against all costs and damages accrued within the period of enrolment.

1.4: Caravan Industry Association of Australia Kid's Club reserve the right to discontinue any child for reasons including but not limited to inappropriate behaviour or illness and injuries.

1.5: Programme Policies and Procedures. By booking your child into the Caravan Industry Association of Australia Kid's Club, you are agreeing to all terms and conditions set out in the Coastal Babysitters Programme Policies and Procedures Manual. The Coastal Babysitters Programme Policies and Procedures Manual has been approved by Child, Youth and Family and is available upon request.

2. CHILDREN'S HEALTH AND SAFETY

2.1 Medical information. In the interests of the child's well-being whilst in the care of the Caravan Industry Association of Australia Kid's Club, Coastal Babysitters' coaches must be informed of any medical or other condition affecting the child.

2.2 Asthma and/or Anaphylactic Health Conditions. In the interests of the child's wellbeing if you have stated that your child/children have Asthma and/or Anaphylactic health conditions then you agree that you must provide the Coastal Babysitters' coaches in charge of the program with their Action Plan and Medication at the start of every Kid's Club session. Failure to do so means the child/children cannot partake in the Coastal Babysitters session and Caravan Industry Association of Australia or Coastal Babysitters cannot be held accountable/liable for any incident that may occur without their Action Plan and medication.

2.3 Parents understand that Coastal Babysitters' coaches do not carry spare Epipens and/or Asthma Emergency packs at the Caravan Industry Association of Australia Kid's Club.

2.4 Parents must inform in writing on the Kid's Club Registration Form if their child/children have Asthma or are Anaphylactic. Coastal Babysitters' coaches are not all Anaphylactic and Asthma trained. Once informed about medical conditions, Coastal Babysitters' coaches can endeavour to ensure the Child has the correctly armband identifying they are Asthma or are Anaphylactic.

2.5 Child's care: Caravan Industry Association of Australia Kid's Club & Coastal Babysitters' coaches are not responsible for children outside of the agreed programme time or for a child making their way to and from a Kid's Club venue.

2.6 Health and Safety Emergencies: In an emergency situation where your child/ren needs medical attention, staff will ensure that every effort possible is made to get hold of the parents/emergency contacts. If contact is unsuccessful, I authorise any person (acting through the staff, employees and contractors of Caravan Industry Association of Australia and Coastal Babysitters) in the event of any accident or illness to my child, to take all such steps as may be necessary for the proper treatment and care of my child and call upon and be advised by a duly qualified and registered medical practitioner to do what it is necessary.

2.7 Parents must sign in and sign out the child/ren at the Kid's Club and no child/ren will be signed out to any other person other than the parent that signed in unless prior notice is given in writing to the Coastal Babysitters' coach.

3. PRIVACY AND COPYRIGHT:

3.1 Photo's: Caravan Industry Association of Australia Kid's Club will occasionally video / photograph during sessions and may use video footage or pictures for promotional or informational purposes. You agree to your child's image/s being used, unless written notification to the contrary is provided at enrolment. If any images are going to be used more widely you will be contacted and an agreement arranged.

3.2 Personal details. Caravan Industry Association of Australia and Coastal Babysitters will not share your details with any third party without your written consent except in the case of 2.6 above.
